



## **INFINITE DANCE STUDIOS - POLICIES & REGULATIONS:**

By enrolling yourself (Students 18+) or your child (Students under 18 years) at Infinite Dance Studios (IDS) classes you (or the child's parent or guardian) acknowledge that you have read, agree to abide by, and (where the context requires) consent to, all of the terms and conditions, codes and policies referred to below.

### TO ENROL AT INFINITE DANCE STUDIOS, YOU AGREE TO ABIDE BY THE FOLLOWING:

### STUDENTS MUST DANCE FROM HOME IF THEY ARE UNWELL.

If any enrolled student of IDS begins to show any cold/flu like symptoms they will be expected to stay home. IDS will provide the option for the enrolled students to participate/watch their dance lesson via Zoom. There will be no refunds for students not attending class due to illness AND/OR if government restrictions require us to stop face-to-face learning. If government imposed restrictions require us to once again close our doors we will revert to immediate online learning platforms. By enrolling with IDS you are agreeing to this approach and understand that you will not be refunded for any fees paid. Any student who does not continue with this option will forfeit their enrolment and will have to re-enrol again if wishing to return. No refunds will be given for any remaining term fees.





# **Key COVID Safe Considerations for Dance Schools**

In addition to the **Safe Work Australia Guidelines** for COVID-19, IDS has the following implemented within the studio to ensure the safety of our students and staff at all times:

### **Contact Tracing**

Infinite Dance Studios keeps up to date roles for all classes and staff. We have a staff member at reception at all times who will check in the students as they enter the studio. Parents are still asked to wait outside the door during drop off and pick up times.

We have parents details entered into our system from their enrolment form. If any details do change it is up to the parent/guardian to inform us via e-mail of these updates. If details need to be passed onto authorities for the purposes of contact-tracing, we will inform parents/guardians before doing so.

Where there is a suspected or confirmed case of COVID-19 at IDS, we will follow the recommended guidelines by the Australian Government and notify our families as directed.

### **Social Distancing**

Infinite Dance Studios has limited the number of dancers in our classes and in the foyer to comply with current state gathering limits.
All IDS staff, students and parents/guardians will be reminded that social distancing must be maintained at all times.
IDS has a carefully planned timetable so it limits any long breaks for multiple students to help social distancing in our waiting room,

bathrooms, and change room.

# Sanitation and Hygiene

Infinite Dance Studios has hired professional cleaners to clean the studios and foyer. Our staff are also wiping down surfaces after each class to keep up with the COVID safe protocols.

Bins are emptied regularly and emptied by Cario Waste weekly. Hand sanitizer is available to all students and teachers at the IDS entrance and studio rooms. Paper towels and soap dispensers are regularly filled in the toilets and hand basins.

All students are to bring their own water bottles from home. Bottled water will be available to purchase from reception.

All staff have completed the COVID-19 Infection Control Training from the Department of Health.

# **General Health and Considerations**

If any staff or student who experiences cold/flu like symptoms, are to stay home. Infinite Dance Studios will continue to keep their Zoom accounts active and available for any student who needs to stay home while they get tested.

If any student/staff member is a suspected COVID-19 positive case, they will be required to self-isolate and seek testing in accordance with state or territory guidelines.

Any student who is classed as high-risk, (as defined by the **Australian Health Protection Principal Committee**) is to attain a medical clearance prior to returning to classes.
